TERMS AND CONDITIONS (w.e.f. 15 Feb. 2002)

1. Mandatory quarantine charges shall be payable on admission of the animal(s) into Jurong Animal Quarantine Station (JAQS). No refund shall be made upon admission of the animal(s). The following mandatory charges (subject to changes) are applicable:
 - (a) Transport from port of entry to JAQS at \$74.00 per animal per trip
 - (b) Rabies vaccination upon admission into quarantine at \$65.00 per vaccination and
 - (c) Basic quarantine space at \$13.50 per day per animal.
 - (d) Optional services can be made available on request at rates prescribed by THE PET HOTEL

2. The designated visiting hours are:
 Mondays to Friday 4.00 p.m. – 6.00 p.m. (wef 15 February 2002)
 Saturdays 2.00 p.m. – 6.00 p.m.
Closed on Sundays and Public Holidays.
 Visitation outside these hours may be specially arranged with THE PET HOTEL, at the latter's discretion. Only the applicant who is the signatory to this application will be allowed to visit the animal(s) described in this application, unless the applicant has made an authorization in the appropriate form obtainable at the quarantine station. Whilst in the quarantine station, the visitor is required to confine himself/herself and his/her animal(s) to the designated areas.

3. Whilst every care and attention is given to all animals in quarantine, THE PET HOTEL shall not be held responsible for any illness, loss or damage, however caused, to the animals in JAQS. In the event of the death of the dog/cat, the dog/cat will be sent for a post mortem.

4. THE PET HOTEL, as required by Agri-Food & Veterinary Authority of Singapore (AVA), will engage an official veterinarian to provide veterinary supervision and advice on the operation and health of animals in the quarantine station. Decisions regarding veterinary care or treatment of an individual animal in JAQS shall be at the discretion of the appointed veterinarian. The applicant shall bear the cost of veterinary treatment.

5. Items that accompany the animal into quarantine are left at the owner's risk. These items may have to be destroyed at the end of the quarantine period.

6. If the applicant is not the owner of the animal(s) described in this application, the applicant is deemed to have obtained the expressed consent of the owner of the animal(s) to represent the owner on all matters for the quarantine of the animal in JAQS and the applicant shall take full responsibility for all claims and costs made against THE PET HOTEL if such claims and costs arise from any misrepresentation made by the applicant.

7. THE PET HOTEL shall have a lien upon any animal in their premises to secure any monies owing by the animal owner to THE PET HOTEL for the quarantine of the animal at JAQS and the owner shall continue to be liable for all charges incurred whilst THE PET HOTEL holds the animal because of its lien.

8. If the owners do not take delivery of the animals within 7 days from the expiry of the quarantine period for any reason whatsoever, THE PET HOTEL shall be entitled to dispose of it in any manner it deems fit without being liable for loss.

9. Owners of dogs/cats shall be notified and given a refund of any advance payments made for quarantine and /or services if there are any changes in the Licensee managing the quarantine facilities while the dogs/cats in question must still be under quarantine as prescribed by the

relevant laws. The said refund shall be given by the present management and shall be limited to advance payments that cover any remaining period of quarantine after the quarantine under the present management.
