

## NOTICE

### NOTARISATION OF SINGAPORE DOCUMENTS FOR USE IN VIETNAM

#### **A. Notarising Government Documents**

- a) All documents issued by the Singapore Government Departments (e.g. *Registry of Marriage Certificates, Birth Certificates and Educational Certificates from local government schools*) in their original text will be directly certified/legalised by:

(i) **Singapore Academy of Law (SAL)**

(ii) Singapore Embassy in Hanoi.

However, computer-generated documents e.g. *Registrar of Marriage Search, Adoption Petition, Business Profile from ACRA, Tax Documents from Inland Revenue Singapore* etc, must be **certified by the issuing department** first, followed by **SAL** before presenting to the Singapore Embassy in Hanoi for legalisation.

**\*Note:** Computer-generated documents from ACRA which have **a QR code** will not need to be certified by ACRA, but can be certified directly by **SAL**.

For commercial documents such as *Invoices, Bills of Sales, Certificates of Origin, Fumigation certificates*, etc, it should be **certified by any of the four Chambers of Commerce** (*International, Chinese, Indian & Malay*) **or the Singapore Manufacturers' Association, followed by SAL** before presenting to the Singapore Embassy in Hanoi for notarisation.

#### **1. Procedure:**

For legalisation of any true copies or true signatures/seal/ stamps documents, please present the original document together with the copies (if you want to certify true copy) to the Singapore Embassy in Hanoi.

#### **2. Processing Time:** 1 working day

#### **3. Processing Fee:**

- For certifying true copy of a document: VND 80,000/ per copy
- For certifying true signature/seal/stamp: VND170,000 per document

#### **4. Submission Time:** Mon-Fri (except public holidays), 9 am – 12 noon.

\* After the original documents are presented and notarised/legalised by the Singapore Embassy in Hanoi, these documents have to be notarised by the **Consular Department of Vietnam Ministry of Foreign Affairs**, located at *40 Tran Phu, Ba Dinh District, Hanoi*, before proceeding to notary public(s) or Justice Division of the District People's Committee for translation into Vietnamese (if needed), before they can be submitted to the local authorities.

### **B. Notarising Non-Government Documents**

#### **1) Procedure:**

All Singapore legal documents such as Power of Attorney, Letter of Authorisation and any non-government documents (foreign / private / company documents/ certificate of private schools or universities) for use overseas are to be notarised as follows:

- a) Notarised by a **Notary Public** (any law firm offering notarial services and must be a member of the Singapore Academy of Law). To be issued with a notarial certificate.
- b) Certified by the **Singapore Academy of Law (SAL)**

- c) Proceed to the Singapore Embassy in Hanoi for certification.

**2) Processing Fee:** For certifying true signature/seal/stamp: VND170,000 per document

**3) Processing Time:** 1 working day

**4) Submission Time:** Mon-Fri (except public holidays), 9 am – 12 noon.
